NABISCO® FALL FOOTBALL SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR TEXT MESSAGE NECESSARY TO ENTER. MAKING A PURCHASE OR SENDING A TEXT MESSAGE WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Nabisco[®] Fall Football Sweepstakes ("Sweepstakes") is sponsored by Mondelēz Global LLC ("Sponsor"), 100 Deforest Avenue, East Hanover, NJ 07936 and is administered by Twelve Thirty, LLC ("Administrator").

- 1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins at or about 12:00 AM (midnight) Eastern Time ("ET") on September 12, 2023 and ends at 11:59:59 PM ET on October 6, 2023 ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY: This Sweepstakes is open only to residents of the 50 United States and the District of Columbia, or such residents stationed overseas with an address in the 50 U.S./D.C. who are: (a) active duty U.S. military personnel, veterans, or family of active duty U.S. military members/veterans; (b) authorized Commissary and/or Exchange patrons; and (c) 18 years of age and older as of the time of entry. Employees, officers and directors of Sponsor, Administrator, Defense Commissary Agency ("DeCA"), Army & Air Force Exchange Service ("AAFES"), The Coca-Cola Company, Coca-Cola Bottlers, HMT Associates, Inc., the National Collegiate Athletic Association ("NCAA"), Turner Broadcasting System, Inc. ("Turner"), and CBS Broadcasting, Inc. ("CBS"), and any of their respective owners, parent companies, affiliates, directors, subsidiaries, representatives, advertising, promotion and production agencies or agents (collectively, the "Sweepstakes Entities") as well as the immediate family members (defined as including spouse, biological, adoptive, and/or step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses. regardless of where they reside) and household members (whether related or not) of any of the above are not eligible to enter or win. Void outside the 50 United States/the District of Columbia and where prohibited by law. All federal, state and local laws apply.

Participation constitutes entrant's (and entrant's parent's or legal guardian's if entrant is deemed a minor in the jurisdiction in which entrant resides ["Minor"]) full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of registration. Entrants will not be allowed to change their physical address or e-mail address on a submitted registration. If it is discovered or suspected that an entrant has registered or attempted to register for the Sweepstakes more than once per calendar day using multiple e-mail addresses, telephone numbers or multiple identities, all of that entrant's entries will be declared null and void and any prize that he/she might have been entitled to win will not be awarded and will be revoked. Use of any automated system or any like methods to participate in the Sweepstakes is prohibited and will result in disqualification of any entrant attempting such use.

3. **HOW TO ENTER:** During the Sweepstakes Period, there are two (2) ways to enter:

a. <u>Text Message</u>: Using an SMS-enabled mobile device, an entrant must send a text message to the short code "80160" ("Short Code") with the keyword "TAILGATE" ("Keyword"). Once the text message is received, the entrant will be sent one (1) reply text message from an automated system asking the entrant to submit his/her date of birth in the following format: "mmddyyyy". Upon receipt of a valid date of birth and Keyword, an entrant will automatically receive one (1) entry into the Sweepstakes ("Text Message Entry"). The winners will each receive up to two (2) additional text messages from an automated system. Only Text Message Entries to the Short Code with the valid Keyword and date of birth will be accepted as a valid Text Message Entry. See Section 6 ("How to Claim a Prize") regarding how potential winners will be notified. All Text Message Entries must be received by Sponsor or its authorized designee by 11:59:59 PM ET on October 6, 2023. NOTE: Proof of text message submission does not constitute proof of delivery or receipt of the text message by Sponsor or Administrator.

IMPORTANT: Message and data rates may apply for each text message sent or received. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes. A mobile device is not required to enter. Entrants should consult their wireless provider's pricing plans. By texting the Keyword to the Short Code, you (or your parent/legal guardian if you are a Minor) provide to the Sponsor and Administrator express written consent for you to receive text messages using automated technology in response to your entry related to the Sweepstakes. Consent to receive text messages is not required or a condition of any purchase. An entrant may, at any time, choose to stop participating in this Sweepstakes by sending an opt-out text message stating "STOP" to the Short Code. If an entrant sends an opt-out text message, he/she will be sent one (1) reply text message, which will confirm that he/she has been unsubscribed and will receive no further text messages. For help, text the word "HELP" to the Short Code. Each Text Message Entry must be manually key-stroked/entered by the entrant.

b. Online Entry: An eligible entrant may also visit nabiscofallfootball.com ("Website") and, on the first visit to the Website, complete and submit the registration form with all required information, which may include, but may not be limited to, first and complete last name (no initials), phone number, street address (no P.O. Boxes will be allowed), city, state, ZIP Code, email address and date of birth. Upon completion and submission of the registration form, the entrant will receive one (1) entry into the Sweepstakes ("Online Entry"). On subsequent visits to the Website, the entrant need only provide his/her valid email address, i.e., the email address provided upon registration.

Each calendar day thereafter during the Sweepstakes Period, depending on the method of entry, the entrant may either text the Keyword to the Short Code, or return to the Website and enter their valid e-mail address, to receive one (1) additional entry into the Sweepstakes.

The Sweepstakes Entities are not responsible for lost, late, stolen, damaged, incomplete, invalid, unintelligible, garbled, delayed or misdirected entries – all of which will be void. Sponsor reserves the right to disqualify any entrant who violates these Official Rules in its sole and absolute discretion.

LIMIT: Regardless of method of entry, there is a limit of one (1) entry per person/e-mail address/telephone number per calendar day during the Sweepstakes Period. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on each calendar day during the Sweepstakes Period.

4. RANDOM DRAWING: On or about October 9, 2023, the Administrator will select one (1) potential Grand Prize winner and eight (8) potential First Prize winners in a random drawing from among all eligible entries received during the Sweepstakes Period through both entry methods combined. Each selected entrant is considered a potential winner pending verification of eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

- **a. Grand Prize (1):** The Grand Prize consists of one (1) \$250 Commissary gift card and one (1) \$250 Exchange gift card. Only one (1) Grand Prize will be awarded. The ARV of the Grand Prize is \$500.
- b. First Prizes (8): Each First Prize consists of one (1) \$50 Commissary gift card and one (1) \$50 Exchange gift card. No more than eight (8) First Prizes will be awarded in the Sweepstakes. The ARV of each First Prize is \$100.
- c. Total ARV: The total ARV of all available prizes in the Sweepstakes is \$1,300.
- d. Odds of Winning: The odds of winning a prize depend upon the total number of eligible entries received during the entire Sweepstakes Period through both entry methods combined..
- e. General Prize Conditions: There is a limit of one (1) prize per person/household. Details of prizes not described herein will be determined by Sponsor in its sole discretion. Each gift card is subject to the policies, terms and conditions of the issuer, which may be printed thereon. If, due to human or other error, the number of prize notifications issued for either prize exceeds the intended number of such prizes, as stated above, the Sponsor will select the winners of the stated number of prizes in a random drawing from among all recipients of such notifications.

Each potential winner who entered via Text Message Entry will be notified via one (1) SMS message from an automated system and must follow the link included in the SMS message notification to submit their valid e-mail address for further notification and winner verification. Each potential winner who entered online will be notified by e-mail with instructions on how to claim their prize. All potential winners may be requested to provide additional documentation for verification purposes within a specified time period. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, fails to timely provide any requested additional documentation, or declines to accept a prize, the prize may be forfeited. If a prize is forfeited for any reason, the prize may be awarded to an alternate winner, selected in a random drawing from among all remaining non-winning entries, as determined by Sponsor in its sole discretion.
